The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

The seller should guarantee the rectification of goods in case of any break down during the guarantee period. 17. Warranty
